# Report by the BIML Director on BIML matters and activities

#### A year of foundation building: Inclusiveness, agility and transformation





# Laying the foundations

- Developing and implementing more adaptive, flexible, contemporary, and fit-forpurpose standards should be a focus for the OIML.
- This will enable the OIML to respond to evolving consumer and industry demands.
- This requires the high frequency review, revision and renewal of OIML publications.
- In doing so the OIML will continue to assert itself as a leading international standard-setting organisation.
- To facilitate the above, the BIML has been working actively with PG conveners and stakeholders, and also proposes a revision of B 6 for CIML approval.





# Foundation: Governance and appointments

- The post 56th CIML Meeting / 16th Conference period was busy with regard to appointed positions and roles.
- These posts are key to the OIML's governance and future:
  - Call for the next CIML President;
  - Establishment of the OIML Digitalisation Task Group (DTG);
  - Call for the OIML DTG Chairperson and Deputy Chairperson;
  - Call for a new CEEMS Advisory Group (AG) Chairperson and Vice-Chairperson;
  - Request for tender for the appointment of an external auditor.





#### Foundation: Formation of the OIML Digitalisation Task Group

- The BIML is actively engaging with, and advancing the digital transformation of legal metrology.
- The DTG consists of 15 representatives from OIML Members and international and regional organisations.
- The DTG will support, coordinate and promote the international harmonisation and implementation of digital transformation in legal metrology.
- The BIML has been very proactive in establishing the foundation for this important horizontal group.





#### **Foundation: Joint Statement of Intent**

on the digital transformation in the international scientific and quality infrastructure

- The "Joint Statement" was signed by the OIML and partner organisations in March 2022.
- It lays the foundations of the work of the OIML DTG and how the international Quality Infrastructure organises itself and its priorities for the future.
- By signing the Joint Statement, the OIML signals its support of the principles contained in it.
- The Joint Statement provides a framework for the OIML DTG and the support and strategic input provided to it by the BIML.





# **Corporate matters and key deliverables**

- During this period the BIML has established more transformative and flexible working practices to reflect the future foundations of the OIML.
- The operating environment is rapidly changing and continually challenging, and the BIML is responding to the opportunities and challenges which arise.
- Some of the key highlights from this period are covered on the following slides.





# Membership

- The OIML is growing and now has 126 Members.
- The Federal Democratic Republic of Ethiopia has re-joined the OIML.
- No OIML Member States nor Corresponding Members were delisted in 2021 – the result of the significant effort and resources deployed to manage Member debt.
- The BIML made considerable effort with a number of South American and Latin American economies, and one Corresponding Member from Africa, with a view to them becoming OIML Member States (including at diplomatic and embassy levels).





#### Governance and the CIML

- Reporting and support was provided to the Presidential Council for its March and October 2022 meetings.
- Multiple Presidential Board and other meetings were convened with the associated preparation and reporting.
- Enhancements were made to the OIML Financial Framework documents.
- The Summary Reports, Resolutions and Draft Minutes of the 56th CIML Meeting and 16th Conference have been published.
- A survey of CIML Members was undertaken to obtain feedback on the selection criteria for future CIML meeting locations.





# Strategy

- The OIML-BIPM Joint Task Group continues to meet and relevant actions were implemented by the BIML.
- There has been continued engagement with the International Network on Quality Infrastructure (INetQI), with BIML IT support.
- Direct liaison continued with UNESCO and relevant UNESCO Member States and permanent missions to advance the OIML and BIPM joint bid for a UNESCO World Day of Metrology.
- Technical input and advice were provided by the BIML to UNIDO as part of the Quality Infrastructure for Sustainable Development Index (QI4SD Index) project.





### Operations

- A major renewal of the OIML website was managed by the BIML, improving both the user experience and the platform software.
- Continued IT software, hardware and backup upgrades were performed.
- Enhancements were made, including simplified and more secure coding, to the databases that interact with the OIML website.
- Structural work was performed on the custom-built CIML voting modules available on the OIML website.





#### **Finances**

- The invoicing system was updated to take account of various Conference and CIML decisions.
- Late payment continues to present an underlying risk to the OIML.
- Inflation continues to present a challenge; more fully realised in forthcoming periods.
- Expenses remain within expectations.
- The OIML Operating Reserve was not accessed during this period.
- The Internal Audit Team recommendations were implemented.
- The 2021 accounts were externally audited and published.
- A Request for Tender was undertaken concerning the external auditor.





# **Technical publication development**

- A variety of new projects have been launched with BIML support given to PG conveners.
- All publications approved by the 56th CIML have been published.
- Updates and progress reports were obtained from PG conveners, and reported to the CIML and PC.
- Work has focussed on approved high priority publications/projects.
- The BIML has assumed a greater role as a convener or co-convener of Project Groups where a Member State has withdrawn.
- Process agreed on the (re)confirmation of conveners and secretariats.
- Numerous and PG meetings have been convened online.
- Work has been undertaken to re-energise certain Project Groups.





# OIML-CS

- The OIML-CS is a key pillar for the BIML.
- It is a recognised multilateral initiative aiming to foster a more harmonised type approval system to benefit all participants.
- The Seventh OIML-CS Management Committee meeting and various meetings of other OIML-CS committees were held.
- The OIML is grateful to those who have contributed to the OIML-CS, especially the Review Committee.
- By directly and effectively engaging with industry, Members can help improve and expand the OIML-CS.

#### CEEMS

#### • The BIML has provided active support to the CEEMS AG, notably on:

- The revision of OIML B 19:2017 Terms of Reference for the Advisory Group on matters concerning Countries and Economies with Emerging Metrology Systems (CEEMS);
- Calls for and appointments of a CEEMS AG Chairperson and Vice-Chairperson;
- The project Use of online technology for conducting CEEMS activities;
- Secretariat work and services to the CEEMS AG in the absence of any co-secretariat support from Members.

# Stakeholder engagement and liaison

- The OIML Bulletin continues to be produced, supported by Mentors.
- The social media outreach and engagement strategy is successful.
- An OIML Style Guide is being developed.
- The refreshed OIML website was launched in early 2022.
- The BIML prepared a report for the Quadrilateral Meeting.
- BIML was invited by the UNECE to present on the Circular Economy.
- The BIML participated in the 61st meeting of the Euro-Asian Council for Standardisation, Metrology and Certification.
- Continued engagement with the OECD *Rule-making Partnership*.
- Continued engagement with RLMOs and RMOs through meetings.





### e-Learning

- The OIML e-Learning strategy continues to be refined and advanced and will interact with the work of the OIML DTG and other bodies.
- The BIML continues to contribute significantly to this strategy.
- Sharing of e-Learning material and other learning resources has increased with and between RLMOs.
- Various in-house hardware and software upgrades have been performed.
- Collaboration on e-Learning continues with the BIPM.
- Work has begun on a joint OIML-BIPM e-Learning module on D 1.





#### Adding value to other organisations' and partners' activities

- During this reporting period the BIML is a member of, and actively contributed to, the following external organising committees for events:
  - 21st International Metrology Congress (CIM 2023);
  - International Conference on Weighing;
  - IMEKO TC6 Conference.





# World Metrology Day

- The 2022 World Metrology Day theme Metrology in the Digital Era

   reflects the importance of digitalisation and digital transformation
   and the significant work of the OIML and the BIPM on this subject.
- The OIML DTG and the Joint Statement directly influenced the choice of the theme for 2022.
- Through the BIML's efforts in conjunction with the BIPM:
  - 2022 theme decided, poster developed, improved website established;
  - Directors' Message and Press Release written;
  - 32 Events, 45 Posters, and 7 Videos uploaded;
  - 7 000 distinct website visitors on 20 May 2022, and 17 400 page visits.





### **Cooperation with the BIPM**

- The BIML has cooperated with the BIPM on many subjects, including:
  - Collaboration with organisations in liaison;
  - Shared messaging, representation, and resourcing;
  - World Metrology Day and the UNESCO bid for a World Day of Metrology;
  - Digitalisation and the digital transformation of our Organisations;
  - The Joint Statement;
  - Organisational, corporate and governance matters.
- Additionally, JTG meetings have been convened and strategy established.
- There is regular dialogue between the Directors.





#### **Emerging matters**

- International standards are most effective when they are widely accepted and trusted. To assess and improve the level of acceptance:
  - The OIML has mapped its metrology functions with UNIDO and the BIML has contributed expertise to the development of the UNIDO QI4SD Index;
  - The OIML's focus is on adding value to society to support the implementation of the SDGs in terms of People, Planet and Prosperity;
  - The OIML DTG will need to consider the most appropriate way to drive sustainability priorities and practices in OIML activities;
  - The OIML must continue to raise the profile of its standards, increase their accessibility and adoption, and reduce their complexity;
  - Feedback must be obtained from consumers and industry.
